- Set up times are on page 1. If you need a set up time outside of these hours it must be scheduled and approved by event staff in email by May 20. Vehicles involved in set up must be moved by 10:15 am.
- All vehicles involved in set up must be out of Osborne Park by 10:15am and taken to the designated vendor parking.
 - ❖ A shuttle will shuttle you back to finish setting up.
 - ❖ You must be ready to vend by 11:00 AM
- You cannot stake your tent down in the asphalt. Please plan accordingly.
- Spaces will be numbered and marked. A map will be emailed prior to the event.
- The City of Euharlee is not responsible for any stolen property or damaged property.
- There will be no refund of vendor fee due to weather conditions, illness, or unforeseen circumstances.
